# Terms and Conditions of UzTEA Membership

Please find below the terms and conditions relating to membership of the Uzbekistan Teachers of English Association (UzTEA). If you have any questions regarding membership, please contact UzTEA.

## Joining UzTEA

1. UzTEA offers different membership categories including Student / Early Career / Retired Membership, Individual Teacher Membership, and Institutional Membership.
2. Membership becomes active once the membership application has been completed and payment has been successfully received.
3. Members will receive access to membership benefits, services, events, and selected resources according to their membership category.
4. Student or discounted membership categories may require supporting documentation to confirm eligibility.
5. Membership is generally valid for twelve (12) months from the date of activation.
6. Membership fees are linked to the officially established **Bazaviy Hisoblash Miqdori (BHM)** of the Republic of Uzbekistan and may change automatically in accordance with government updates to the BHM amount:
  - Student / Early Career / Retired Membership – **0.5 BHM**
  - Individual Teacher Membership – **1 BHM**
  - Institutional Membership – **5 BHM**
7. Membership fees are automatically adjusted in line with any official changes to the BHM established by the Government of Uzbekistan.

## UzTEA Code of Conduct and Policies

8. Members are expected to maintain professional, ethical, and respectful behaviour in all UzTEA-related activities.
9. Members must comply with UzTEA policies, event guidelines, and community standards.
10. UzTEA reserves the right to suspend or terminate membership in cases of misconduct, abuse, or serious policy violations.

## Membership Benefits and Events

11. Membership benefits may include webinars, conferences, networking opportunities, discounts, publications, and access to professional development resources.

12. Certain activities, conferences, or partner services may be subject to additional terms and conditions.

13. UzTEA is not responsible for external services or third-party platforms associated with partner activities.

## Your personal information, contacting you and your preferences

As explained in the UzTEA Privacy Policy, we collect and process personal information in order to provide membership services and organisational communications.

Members will receive essential communications relating to membership, renewals, events, elections, announcements, and association activities.

Members may choose whether to receive additional newsletters, updates, promotional communications, or partner information.
